NOTICE OF EXTRAORDINARY GENERAL MEETING AND 2026 MANAGEMENT COMMITTEE ELECTION

Notice is hereby given that an Extraordinary General Meeting (EGM) of the MMA Association of Singapore (MMAAS) will be convened by order of the Board for the purpose of conducting the 2026 Management Committee Election.

1. PURPOSE

The EGM is convened for eligible voting members to elect Elected Board Members for the applicable positions in the 2026 election cycle. The election will be administered in accordance with the MMAAS Constitution.

3. ELECTION AND NOMINATION

Nominations for the 2026 Management Committee Election will open on 5 September 2026 and close on 18 September 2026 at 2359 hrs (Singapore Time).

- All nominations must be submitted using the prescribed nomination form together with any required supporting documents.
- Each nomination must be proposed by a Full Member and seconded by another Full Member.
- The nominee must declare any personal or business interest that may be of concern to MMAAS or its members.
- Nominees must satisfy the applicable eligibility requirements for Board Members and Elected Board Members under the MMAAS Constitution.

4. VERIFICATION AND CANDIDATE ANNOUNCEMENT

MMAAS will verify the eligibility of nominated candidates, voting Full Members and their authorised delegates in accordance with the Constitution. The confirmed list of eligible nominees is scheduled to be published on the MMAAS website and circulated to members on 22 September 2026.

5. ATTENDANCE AND AUTHORISED DELEGATES

All MMAAS members may attend the EGM. Each Full Member is entitled to appoint one (1) authorised delegate to attend, speak and vote on its behalf.

The name of the authorised delegate must be notified to the Secretary-General at least three (3) days before the EGM.

6. VOTING AND ELECTION PROCEDURE

- Only eligible authorised delegates of Full Members who are above 21 years of age may vote in the election.
- Each authorised delegate has one (1) vote.
- Proxy voting is not permitted.
- Electronic voting is permitted for a General Meeting conducted by electronic means.
- The election will be conducted or supervised by an independent member of the Board.
- Voting will be by secret ballot and the result will be based on a simple majority of votes cast.
- The counting of votes will be overseen and verified in accordance with the MMAAS Constitution.
- Any tie affecting the outcome of the election will be resolved in accordance with Article 19 of the MMAAS Constitution.

7. FOLLOWING THE ELECTION

Following declaration of the election results, the newly constituted Board will determine the Key Office Bearers from among themselves in accordance with the MMAAS Constitution. Any resulting change of Board Members will be notified to the Registrar of Societies and the Commissioner of Charities within the timeframe prescribed by the Constitution.

8. GOVERNING DOCUMENT

This notice should be read together with the Constitution of the MMA Association of Singapore. In the event of any inconsistency between this notice and the Constitution, the Constitution shall prevail.
